Topic: Appointment of Designated Representative to Negotiate Potential Amendments to Bargaining Unit Memorandums of Understanding

Recommendation: Staff recommends that the Board of Directors appoint Jenica Maldonado as the Novato Fire Protection District's ("District") designated representative in negotiations concerning potential amendment to the terms and conditions of employment in Memorandums of Understanding with its three employee organizations.

Background: The District recognizes three employee organizations—the Novato Professional Firefighters Association, IAFF 1775 ("NPFA"); the Novato Fire Chief Officers Association, IAFF Local 1775 ("NFCOA"); and the Non-Sworn Administrative Staff ("NSAS"). Each of the memorandums of understanding concerning the terms and conditions of employment between the District and these employee organizations are set to expire on June 30, 2025. The District intends to meet its legal obligation under state law to meet-and-confer with each of the employee organizations concerning potential changes to these MOUs and to appoint a Chief Negotiator to represent the District in these negotiations.

The purpose of this agenda item is to recommend that staff appoint Jenica Maldonado, a partner at the law firm Atkinson Andelson Loya Ruud & Romo, as the District's designated representative in these upcoming negotiations, in accordance with Government Code section 54957.6. Staff also recommends that the scope of Ms. Maldonado's appointment include negotiations regarding topics that the parties had intended to address prior negotiating the MOU terms, including potential changes to District personnel-related rules and policies and to identify District past practices.

The negotiation topics identified in this agenda report constitute matters that are within the scope of representation under the Meyers-Milias-Brown Act ("MMBA"), Gov. Code sec. 3500 et seq.
